August 6, 2015 – OurCrowd, the world's leading equity crowdfunding platform, today announced that two of its portfolio companies, <u>ElMindA</u> and <u>Consumer Physics</u> were named by the World Economic Forum to their prestigious list of "<u>Technology Pioneers 2015</u>," a selection of 49 of the world's most innovative companies. This annual award is granted to companies "poised to have a significant impact on business and society," and past recipients have included companies like Google (2001), Twitter (2010), AirBnB (2014), Dropbox (2011) and Kickstarter (2011).

Consumer Physics and ElMindA were selected from among hundreds of applicants by a <u>selection</u> committee of 68 academics, entrepreneurs, venture capitalists and corporate executives. Notable members of the committee include Arianna Huffington (founder, Huffington Post) and Henry Blodget (editor-in-chief, Business Insider). The committee based its decisions on criteria including innovation, potential impact, working prototype, viability and leadership. Thanks to its selection, both companies will have access to the most influential and sought-after business and political network in the world, and be invited to the World Economic Forum's "Summer Davos" in Dalian, China, this September, or the Annual Meeting in Davos in January.

"We are so proud of ElMindA and Consumer Physics for being named to the 2015 WEF Tech Pioneers List," said OurCrowd CEO Jon Medved. "This list represents the best of the best in promising global technology companies, proving that equity crowdfunding will provide investor access to unprecedented opportunities."

Award winner Consumer Physics is the maker of SCiO, the world's first molecular sensor that fits in the palm of your hand. SCiO allows users to explore physical materials, so they can scan food in the market to make sure you choose the sweetest watermelon or the best cheese. Dror Sharon, CEO of Consumer Physics said, "OurCrowd was among our earliest investors and their backers believed in our vision even before we had a prototype. OurCrowd has played a large part in our success, adding value and driving us forward."

Award winner ElMindA has developed the Brain Network Activation (BNA), a non-invasive technology that allows physicians to accurately differentiate between the function of a healthy brain and the dysfunction of an injured brain. This will provide the ability to assess and treat the brain across a broad range of previously elusive conditions such as concussion, depression, pain, or memory loss. ElMindA's CEO Ronen
